DIRECTOR OF FIELDS

Received estimates for field treatment is \$4900 for fertilizer and \$1000 for aeration each occurrence. CYSA approved going forward with two treatments. Total is about \$10600 (about \$500 more than last year). Company has a new name “RSD LLC”. Check was given to Jeff to cover the cost.

Karen, Lisa and Chris all participated in the new database WeGotSoccer training. Feedback based on the training was that this was a very good system compared to the older database and our folks really like the flexibility it offered. Cost is going to run about \$1 per child.

NEW BUSINESS

Competitive Uniforms – Xara come forward and informed Dan that they are running out of the cloth associated for our uniforms, (Xara originally told us we would get 5 to 7 years out of the current uniform (we are at the end of year 4). Colin suggested the following steps to help with integrating the new uniform –

- 1) Stop current U-8 uniform request and transition entire team over to the new uniforms, those that purchased uniforms last year will get their uniform free, all others at cost.
- 2) All other uniforms will be purchased in the “old” style. This season.
- 3) Next year new U10 uniforms for the U10 kids remaining (2nd year U10) will be offered at a discount (\$15 shirts). All other shirts will be offered in the “old style” to back fill. (XARA feels that they can backfill for a couple more years.

Other Options Include - We could buy 2 yr uniforms for about \$25.

Board voted to accept the Xara offer to buy new U8 uniforms for this spring season and back-fill for as long as possible.

Board Member Jackets - Jackets for CYSA board members for rec season. Will discuss this at next meeting.

New Rec Uniforms – Discussed going to a soccer style shirt for the rec program. Inara has “throw away” uniforms for around \$12 per kid + the cost of finishing. We currently pay \$6 per shirt and \$3.50 for shorts and \$1 for socks.
